Plaintiff supplements her Answering Brief by citing *State v. Fischer*, No. CR-15-0380-PR 2017 WL 1374694 (Ariz.Sup.Ct., April 17, 2017). *Fischer*, a criminal case, is also applicable in civil matters. *Id.* at *2 ¶ 11. It is cited in sup-

port of all portions of Plaintiff's brief dealing with a trial judge's broad discretion to see that a verdict is fair and just. More specifically, *Fischer* is cited in support of the following:

1. *Fischer, id.* at *2-*4 ¶¶ 11-18, *6 ¶¶ 22-24: Answering Brief at 36-39 concerning the extent of trial judge's discretion when the judge deems the jury verdict is unjust.

2. *Fischer, id.* at *6-*7 ¶¶ 26-31, Answering Brief at 36-38 regarding standard of review.

3. On the extent of relief due under Rule 60(b)(6), Ariz.R.Civ.P., Plaintiff cites the portion of *Klapprott v. United States* that states: "Fair hearings are in accord with elemental concepts of justice, and the language of the 'other reason' clause of 60(b) is broad enough to authorize the Court to set aside the default judgment and grant petitioner a fair hearing." 335 U.S. 601, 615 (1949). See Answering Brief at 38-39.
